Touchdown. Assuming the pylon was placed properly, the ball broke the plane of the goal line prior to the touching of the pylon.

During (a) A9's run for a touchdown, B2 holds A1, or (b) K1's field goal, R2 holds K1.

What is the ruling?

In (a), A will likely keep the score and may choose to enforce the penalty on the try or enforce the penalty on the subsequent kickoff. In (b), K may keep the points and have the penalty enforced from the succeeding spot, or have the penalty enforced from the previous spot and replay the down. (8-4-3)

In both cases, the opponents of the scoring team commit a live-ball foul

What is the ruling?

In (a), the offended team has the option to keep the score, with the penalty assessed on the second half kickoff as this is the succeeding spot. In (b), the offended team has the option to keep the score, with penalty assessment on either the try or on the second half kickoff as this would be the subsequent kickoff.

RULING: In (a) and (b), the touchdown will be scored. The offended team will have the option to enforce the penalty on the try or carry it to the subsequent kickoff

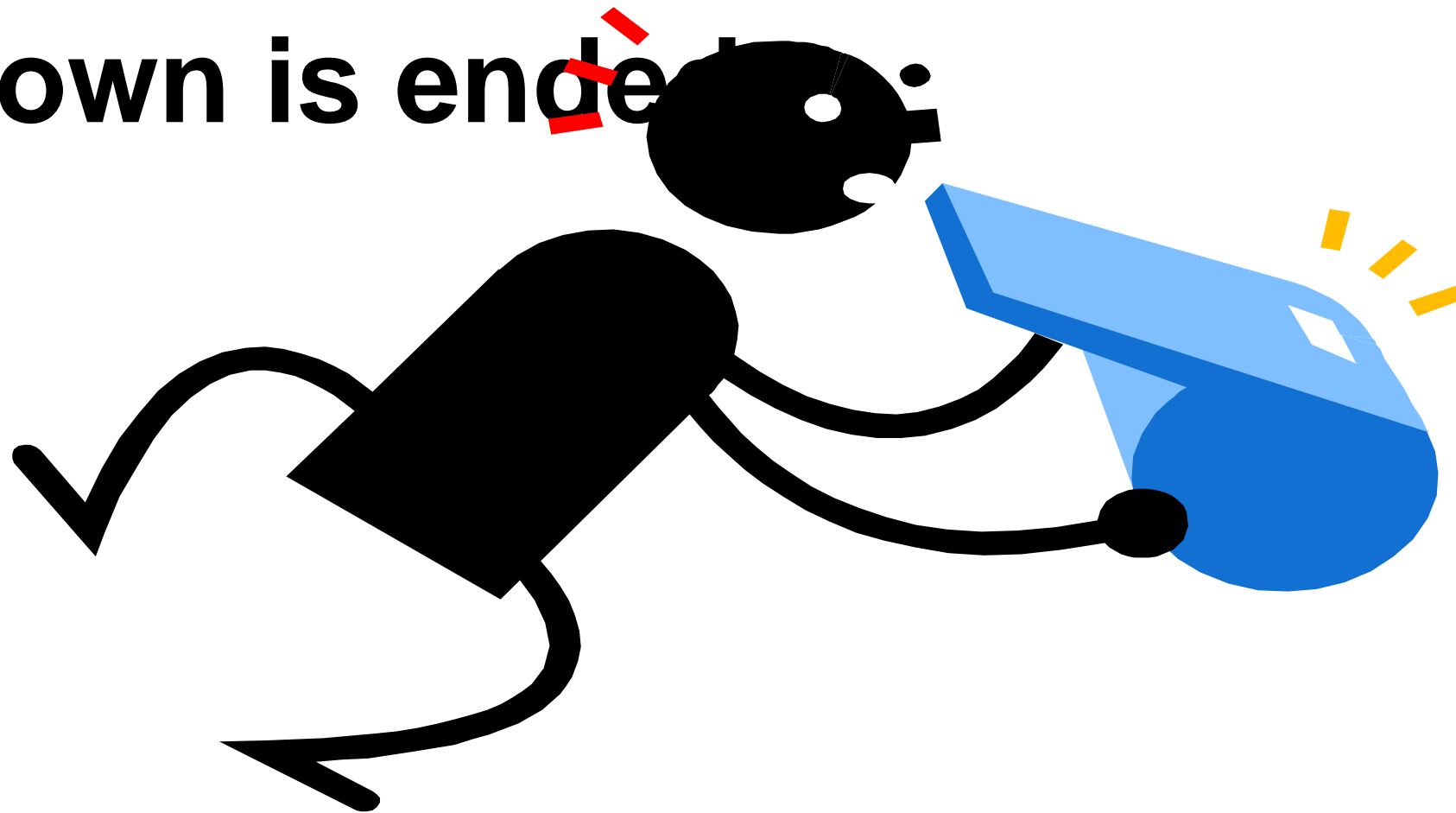

NFHS Rule 4.2.2j

**The ball becomes dead and the
down is ended**



Inadvertent Whistle

NFHS Rule 4.2.3

If there are NO penalties, or if the penalty for a foul during the down is DECLINED:

- **replayed if the whistle occurs while a legal forward pass or snap is in flight OR during a legal kick.**

Inadvertent Whistle

NFHS Rule 4.2.3

Loose ball following a backward pass, fumble, illegal forward pass or illegal kick

team last in possession can:

- Replay the down**
- Count the down & put the ball in play where possession was lost.**

Inadvertent Whistle

NFHS Rule 4.2.3

In player possession

- Replay the down.**
- Count the down, accept the results of the play at the spot of the inadvertent whistle.**
